- 3. What role do parks and open space have in your goals for climate adaptation and mitigation?

- 7. On a per capita basis Boston spends between ¼ and ½ of what Seattle and San Francisco spend on parks. How can Boston increase the park budget while not negatively impacting other vital city services?
 When we invest in healthy environments, the return on investment is much greater. Investing in our park budget has the potential to decrease the need for reliance on other line items associated with health care and public safety, etc.
- 8. What do you think are some of the most challenging current questions about competing demands for parkland and other open space? How would you approach challenging decisions about parkland and open space use? The demand for more housing and services that come along with housing, in addition to increased public safety concerns, provide a challenge for parkland and open space for competing funds. There is always the need to prioritize based on needs and funding availability but I would suggest that we acknowledge the investment in parks and open space as not only an immediate amenity but a preventative and mitigating tool for other issues.
